



The Gospel of Matthew records the words that our Lord Jesus spoke when He delivered the Sermon on the Mount. Part of that life-changing sermon says, "Ye are the light of the world. A city that is set on a hill cannot be hid" (Matthew 5:14).

Some of the earliest English settlers in America were well aware of this verse. For example, when John Winthrop was aboard the *Arbella*, he delivered a famous sermon titled "A Model of Christian Charity." Referring to Matthew 5:14, Winthrop preached, "For we must consider that we shall be as a city upon a hill. The eyes of all people are upon us."

Many years later, President Ronald Reagan used Matthew 5:14 and Winthrop's sermon to describe his vision of American exceptionalism, and in his Farewell Address, he spoke of America as "the shining city upon a hill."

This example demonstrates that the United States has a strong Christian heritage, but countless other examples could be identified. When the Pilgrims arrived in New England on November 11, 1620, they signed the Mayflower Compact which begins, "Having undertaken for the glory of God and advancement of the Christian faith..."

During the Constitutional Convention, Benjamin Franklin asserted, "I have lived, Sir, a long time, and the longer I live, the more convincing proofs I see of this truth—that God governs in the affairs of men. And if a sparrow cannot fall to the ground without His notice, is it probable that an empire can rise without His aid?"

George Washington's Thanksgiving Proclamation of 1789 begins, "Whereas it is the duty of all nations to acknowledge the providence of Almighty God, to obey His will, to be grateful for His benefits, and humbly to implore His protection and favor...."

Sadly, many secularists are all too happy to kick God out of the public square these days. People who delight in being offended claim that the mention of God harms them. Some

smooth-talking legislators try to make it easy for anti-God messages to be proclaimed, but hard for pro-God messages to be heard.

As Christians in America, we can truly be thankful for our religious heritage. At the same time, we cannot suppose that our religious freedom will endure forever if we do not actively do our part to assure it does. In a practical sense, it does us little good to have the right to own and read a Bible if we never do so; and it seems almost pointless to have the constitutional freedom to share the message of the Gospel if we never do so.

As we reflect on our nation's founding, we should renew our desire to follow the way of the Lord. We should never forget the power of prayer and the Scriptural commands that instruct us to pray for our political leaders. President George W. Bush said, "I am sustained by the prayers of the people in this country. I guess an appropriate way to say this is that it is one of the beautiful things about America. Americans from all walks of life are willing to pray for the President and his family. And that's powerful. It's hard for me to describe to you what that means."

When election seasons approach, we should be sure that we are registered to vote, and we should vote with our Christian values in mind. When policies and laws are considered in our towns and cities, we should stand for truth, morality, and sanity.

THE **IMPORTANCE** OF **VIRTUE**

In the first chapter of 2 Peter, the Apostle used the word *virtue* twice. In 2 Peter 1:3, he taught Christian people

that they have been called to "glory and virtue." Just two verses later, the Bible admonishes Christians to "add to your faith virtue" (2 Peter 1:5).

The word *virtue* suggests moral excellence. God's people are commanded to conscientiously add moral excellence to their Christian faith, and this is not something that can be done incidentally or accidentally.

Christians who have worked hard on adding virtue are usually able to weather storms with a gracious attitude. The character they exercise to add virtue seems to simultaneously give them patience and grace.

When Christians are sued for the faith, nothing makes a better impression on a jury than people who are truly good people, people who have done their best with the power of the Holy Spirit to be morally excellent people as the Bible commands.

ESTABLISHING BIBLE CLUBS IN PUBLIC SCHOOL

During these days, many people have the wrong idea that Christians have no rights at all in

their local public schools. Though it is true that the government forbids teachers from evangelizing students, it is not true that the students themselves have to shed their religious liberties when they attend public school. If your local school allows students to form clubs, then they must allow students to form a Bible club. In order to establish a Bible club properly, it must

be an idea initiated by the students, and it must be organized and operated by the students. In other words, members of the public school staff cannot direct the teaching of the club.

Most schools require each club to have a staff sponsor. In the case of a Bible club, sponsors can help students interact with the administrative policies of the school, but they cannot teach Bible lessons—or direct students about what should be discussed.

CHURCH SECURITY TEAMS

In modern America, it is essential for churches to have effective security teams. But when churches begin to establish these teams, they often are faced with many tough questions like these:

- "Should the security team be armed or unarmed?"
- "Should the security team utilize active and/or retired police officers?"
- "Should the security team include former members of the military and/or those on active duty?"
- "What role does the church insurance company need to play in determining effective security policy?"

In many cases, churches need the advice of seasoned attorneys who understand the details of their state law, attorneys who have seen the effectiveness of many different approaches to church security and have handled negative situations caused by problematic policies that are best avoided.

In the 1600s, the nation of England had some unstable religious laws. If a Protestant became King, the official state religion became Protestant, and there were penalties for Dissenters. But if the next monarch was Catholic, the official state religion became Catholic. Everyone had to happily convert, or at least pretend to do so, unless they were willing to suffer religious persecution at the hands of the new monarchy.

In light of this persecution, many Pilgrims and Puritans made the life-altering decision to leave behind everything they knew and give all they had, often sacrificing their lives, to make the treacherous and difficult journey to North America. They were a people seeking freedom to worship and stability in the law.

Still, over time, the English government began to assert more control of the North American colonies. Eventually, heavy taxes began to be levied on the Americans, even though they had no representatives in the British Parliament.

Wanting to be completely free from British rule, the colonists eventually decided to break away from England. Because of their belief that God grants people basic

human rights, honorable men crafted the Declaration of Independence to proclaim that men are "endowed by their Creator with certain unalienable Rights." And these founders of our nation gave their all for the chance to live a life where they were free to exercise those rights.

The Revolutionary War was brutal, but, against all odds, the Americans succeeded in that effort to secure their independence from England and set about establishing a new nation.

Today, our nation is quickly losing its way. National pride is a thing of the past in many places in our country. Those who wish to deny American citizens the freedoms that our great land has offered since its inception have done much to bring that to pass by purposely failing to teach the next generation the history of how and why America came to be.

Parents, please take the opportunity on this fourth of July to teach your children why we celebrate the signing of the Declaration of Independence. Freedom is never free, but coming generations will never appreciate what they are never taught.

KEEPING THE MUSIC IN TUNE

It may be hard to believe, but church music programs have the ability to cause serious legal and financial problems for a church!

Many times, church musicians don't give a second thought to photocopying music for the church choir. But even if your church has a copyright license, such as the licenses available from CCLI, you do not have permission to copy music for the choir. If you are ever sued for this, the financial penalties are enormous and could potentially bankrupt most ministries!

Be sure you have the licenses you need for livestreaming your services. Remember, you can freely livestream the preaching of the Gospel, but livestreaming copyrighted music can result in a legal nightmare. In some scenarios, churches make recordings of music and sell them

to members and to friends of the ministry. What they forget or neglect to explore is the requirement to pay licensing fees when recording copyrighted music. This is not optional, and the details can sometimes be tricky. For example, the song "Amazing Grace" is in the public domain and can be recorded freely—but a specific arrangement of "Amazing Grace" may be copyrighted, and a license would be required in order to record the arrangement.
